

**We, the undersigned physicians and scientists, demand:**

**An immediate halt to the use of dangerous modRNA (modified RNA) and saRNA (self-amplifying RNA) technology in humans and animals, as well as a scientific investigation of the excesses of the Covid measures, so that such violations of fundamental rights can never happen again.**

From 2020 to 2025, an unprecedented social and medical experiment took place—one that demanded economic, cultural, social, and health-related sacrifices on a scale never before seen by people on this planet. It caused massive and still ongoing devastation, leaving behind, in unparalleled numbers, people who fell ill, who suffered lasting harm, and people who lost their lives.

Yet there was no virus in 2020 that was as deadly as claimed by the WHO and by health authorities in Europe and around the world.

In 2020 there was neither excess mortality nor the threatened hospital overcrowding, nor were all age groups equally affected by SARS-CoV-2. Quite simply, there was no pandemic, but rather a modelled one—created through an unsuitable PCR test that produced a large proportion of so-called “asymptomatic patients.”

With near-certainty, the pathogen responsible for Covid was an artificially engineered virus produced through gain-of-function genetic manipulation, quite possibly even a deliberately created bioweapon. (1) (2)

For the unimaginable and historically unprecedented restrictions of freedom and fundamental rights—measures such as lockdowns, school closures, mask mandates, and compulsory vaccination—there was neither scientific evidence nor legal justification. (3) Thus, there was and is no basis for any of these measures. Everything ordered or, in part, enforced as a Covid measure was therefore unlawful and constitutes a crime against humanity. Fundamental and human rights were consequently violated arbitrarily and without necessity.

In spite of clear evidence to the contrary (4), all of these measures were enforced by political authorities. In this regard, the European Commission, the ECDC (European Centre for Disease Prevention and Control), and the EMA (European Medicines Agency) bear grave responsibility. Although scientists and physicians at the Robert Koch Institute in Berlin internally debated the situation in a scientifically correct manner, they were instructed by the Ministry of Health and by Surgeon General H.U. Holtherm to publicly justify the government’s course with false “scientific” arguments. This is proven beyond doubt by the minutes of the RKI crisis team meetings between 2020 and 2023, which were brought to the public in 2024 by a courageous whistleblower. (5) Politics issued the orders, science followed — as did the mainstream media, the judiciary, and state institutions.

Dissenting voices were excluded from public discourse, defamed, prosecuted, and convicted — including around 1,000 physicians in Germany for issuing mask exemptions and medical certificates of vaccine contraindications, as well as an estimated thousands of their patients.

**What have the mass injections of modified RNA — the so-called Covid vaccines — achieved?**

Since 2021, we have observed an excess mortality that correlates in time with the beginning of mass vaccination and continues to this day in many countries; likewise, a persistently reduced birth rate; and an increase in various diseases even among non-risk groups, such as heart attacks, strokes, vascular and nerve inflammation, and cancer. (6) The massive rise in post-infectious syndromes, infectious diseases, degenerative and autoimmune processes — in particular the sharp increase in chronic fatigue syndromes — is also closely linked in time to the widespread use of the dangerous modRNA technology. (7) As a result, overall life expectancy is declining. (8)

To this day, there is hardly any balanced and honest review of the Covid period — neither by the responsible institutions nor within society. An open-ended discussion within the scientific community is still completely absent. Decision-making bodies such as the medical councils continue to shut themselves off from truth-seeking and open discourse regarding facts such as the RKI files, etc.

**We, the undersigned of this declaration, therefore demand:**

- Immediate cessation of the use of mod-RNA (modified RNA) and saRNA (self-amplifying RNA) technology until it can be demonstrated beyond scientific doubt that the benefits outweigh the harms.
- Immediate prohibition and condemnation of gain-of-function research.
- Full restoration of physicians' therapeutic freedom in all areas, free choice of therapy for patients, and personal liability of every physician for providing medically necessary and complete informed consent before the application of treatment and preventive measures such as vaccinations.
- No more lockdowns, as there is no scientific basis for them.
- No more mask mandates in public, as harm has been demonstrated but no benefit.
- No more compulsory vaccination and no further vaccine coercion for social participation or employment.
- No more measures without risk assessment.
- No more misuse of the Infection Protection Act to restrict fundamental rights.
- Establishment of complete political and economic independence for all scientific advisory institutions such as the RKI, PEI, STIKO, etc.
- No political interference whatsoever in physicians' therapeutic freedom.
- No further misuse of science for political agendas.
- Immediate termination of all ongoing legal proceedings and full rehabilitation of all physicians, medical personnel, and patients convicted of so-called Corona offences.
- Never again measures imposed by the WHO without independent evaluation, risk assessment, and a democratically legitimized decision; no authority of the WHO that stands above national sovereignty.
- A public, critical, honest, and open-ended review of the Covid period and all measures of that time—within the media, parliaments, committees, and society.
- Holding responsible decision-makers legally accountable.
- A public, open-ended debate on the future involvement of the population in all areas that directly affect them.
- Never again censorship of critical voices, scientists, or media, nor any form of press uniformity.
- Immediate prohibition of nudging and other techniques of psychological warfare used against the population.
- Never again the manipulation of a "state of emergency" by democratically illegitimate bodies, such as a "conference call of the state premiers with Merkel."
- Decoupling of state, economy, science, judiciary, and media, with clear separation of powers and a free press as the foundation for democratic opinion-building. A democratic, open society requires transparency and unfiltered access to information as the basis for each individual's decisions.

**Politics must never again seize power over health, therapy,  
or the free medical profession, nor issue directives to physicians.  
Crimes against humanity of this kind must never be possible again — and no  
transfer of authority to the WHO or any other body lacking democratic  
legitimacy must ever be permitted.**
